Structural reliability theory is concerned with the rational treatment of uncertainties in structural engineering and with the methods for assessing the safety and serviceability of civil engineering and other structures. It is a subject which has grown

Uncertainties exist in most areas of civil and structural engineering and rational design decisions cannot be made without modelling them and taking them into account.
